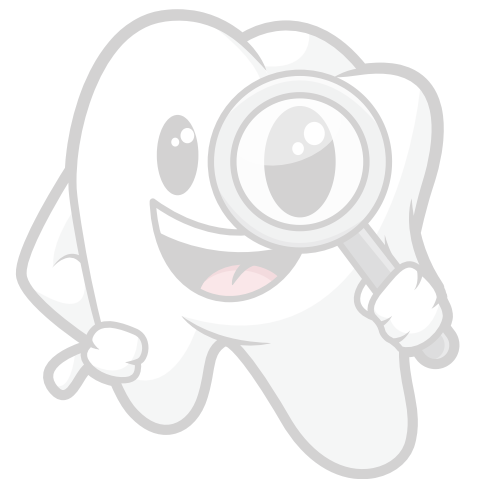

Enrollment can begin as soon as you subscribe, and after training, you will receive complete enrollment and digital setup in one go, streamlining your services and operations.

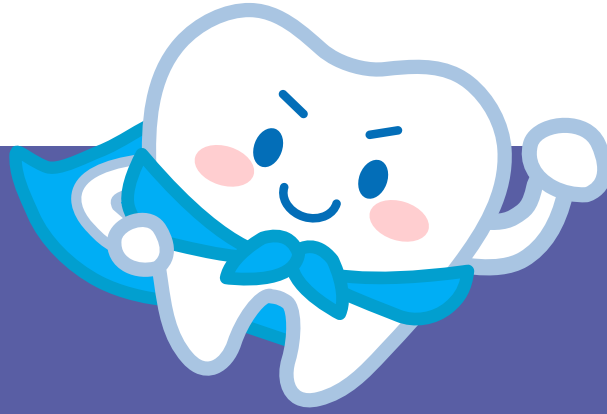
